# **Comparative Study on Economic Ministries/Agencies of the Governments of the ROK, Japan and China**

## **I. Introduction**

Governments of the Republic of Korea (ROK), Japan and the People's Republic of China play a pivotal role in promoting the trilateral cooperation. There remain potentials for the three governments to expand cooperative areas and mechanisms. This comparative study aims to provide better understanding of organizational structures of three governments' economic ministries/agencies, and facilitate further institutionalization of the trilateral economic cooperation.

The TCS has conducted this study on its own initiative and on basis of open sources, i.e. official websites of the three governments. A database of ministries/agencies with their functions and contact information at department level is compiled (Annex I), by which relevant ministries/agencies may look up for their counterparts in the other two governments.

This study is non-exhaustive. Further confirmation and consultation by the ministries/agencies are highly welcome.

## **II. Economic Ministries/Agencies of the Three Governments**

China, as a fast developing nation with vast territorial space and population as well as a legacy of planning economy, has established a large-scale economic administration system. Under the central government, i.e., the State Council, there are about 30 ministries/agencies with detailed division of labor and operating on an equal footing. The ministries/agencies have detailed mandates at department level as well. In particular, the National Development and Reform Commission (NDRC) oversees overall macroeconomic development and covers comprehensive economic affairs. The Ministry of Commerce (MOFCOM) holds the authority for foreign trade and investment.

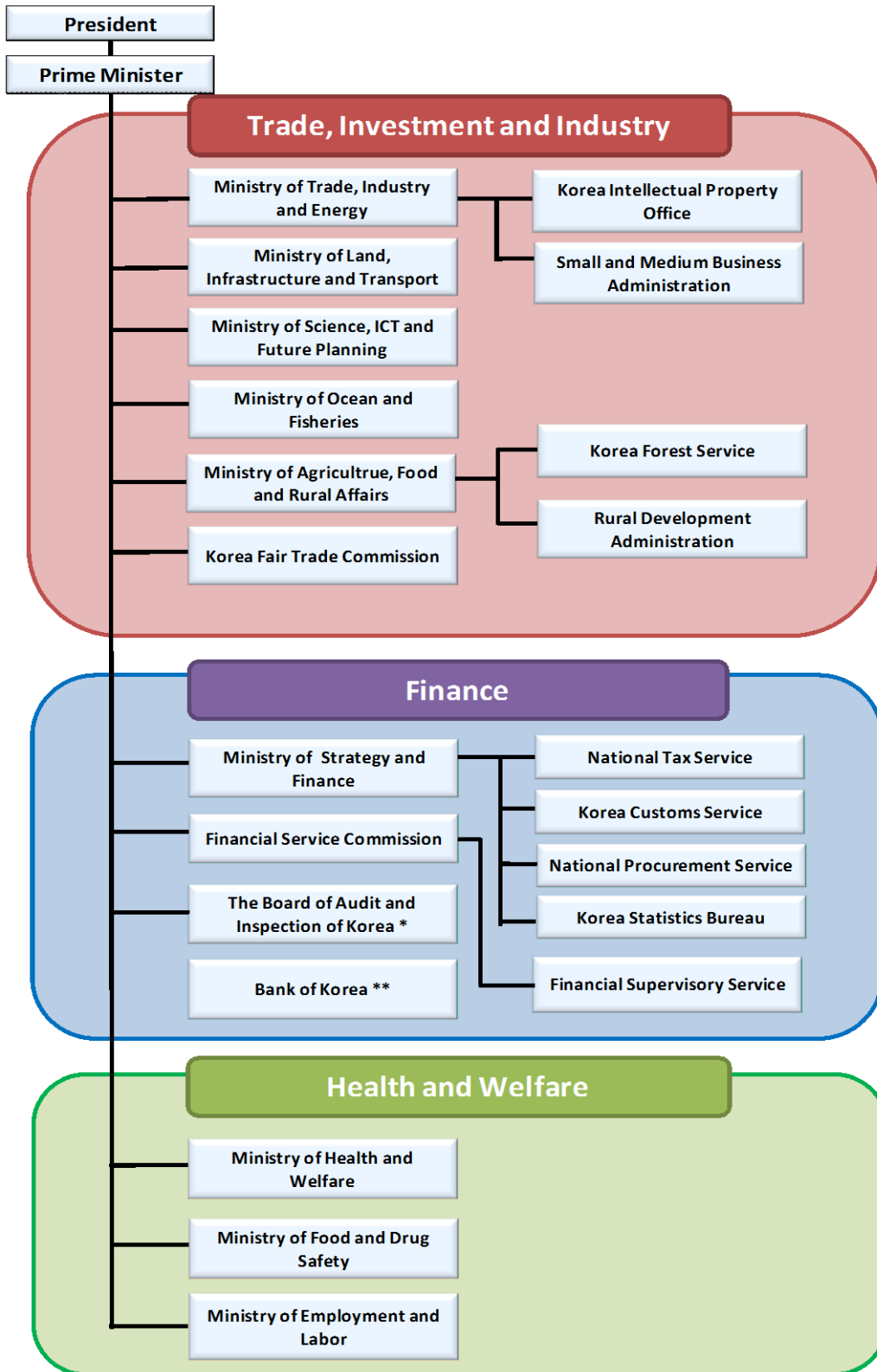
In contrast, ministries/agencies of the ROK and Japan are endowed with more integrated structures and broader mandates. Though smaller in total number as well as manpower, several bureaus and agencies for external affairs have extensive jurisdictions for international cooperation, such as the Japanese Ministry of Economy, Trade and Industry (METI) and the ROK Ministry of Trade, Industry and Energy (MOTIE).

Both the ROK and China made realignment of ministries/agencies in 2013 to accommodate policy goals of the new administration. Japan's government structuring has mostly remained unchanged in the past decade.

The following are the overviews of economic ministries/agencies of the three countries:

**i. ROK**

The Park Geun-hye administration has 12 economy-related ministries and 9 agencies under them.

## 1. Trade, Investment and Industry

### **Ministry of Trade, Industry and Energy (MOTIE)**

Promoting foreign trade and foreign direct investment; establishing innovative research and design system; upgrading flagship industries such as automobile, shipbuilding, semiconductors, steel, general machines, textiles, parts and materials; engaging in energy cooperation projects; developing renewable resources; managing national energy supply; and crafting environment-friendly economic policies.

*Korea Intellectual Property Office (KIPO)* is in charge of the management of intellectual property rights.

*Small and Medium Business Administration (SMBA)* provides supports to SMEs.

### **Ministry of Land, Infrastructure and Transport (MLIT)**

Building infrastructure, transport, and logistics network including roads, railroads, air transport, and construction of dams; managing traffic safety; conducting city planning and management of living environment; managing land use and industrial complex for regionally balanced development.

### **Ministry of Science, ICT and Future Planning (MSIP)**

MSIP is a newly formed ministry in the Park Geun-hye's administration responsible for promoting Creative Economy by combining the areas of science, technology and ICT; promoting basic and fundamental science, convergence technology, space and satellite science, broadcasting and communications, standardization of Internet related technology, ICT, and telecommunications technology.

### **Ministry of Oceans and Fisheries (MOF)**

Promoting the development of maritime resources, maritime energy technology, shipping industry and harbors, fishery industry and maritime plants; managing water resources and ocean safety; administering maritime territory jurisdiction including fishery rights in the Exclusive Economic Zone (EEZ).

### **Ministry of Agriculture, Food and Rural Affairs (MAFRA)**

Promoting high-tech industrialization of agriculture; encouraging competition among distribution channels and enhancing system for agricultural supply and demand; promoting the reduction of farm operating costs; enhancing living conditions and establishing social safety net in the rural areas; and promoting stable supply of safe agricultural and livestock products and raising grain-independence ratio.

*Korea Forest Service* is in charge of forestry industry.

*Rural Development Administration (RDA)* is in charge of agricultural science and technology.

### **Korea Fair Trade Commission (KFTC)**

KFTC is a ministerial-level administrative organization under the Prime Minister. Its duty includes creating a competitive market environment by reforming anti-competitive regulations and regulating Mergers and Acquisitions with anti-competitive effects; protecting consumers from unfair adherence contracts; securing the basis of development for small and medium sized subcontractors; and correcting expansion-oriented management of large companies.

## **2. Finance**

### **Ministry of Strategy and Finance (MOSF)**

Designing mid to long-term national development strategies; formulating economic and fiscal policies; managing budgets and public funds; monitoring expenditures; administering policies of taxes, tariffs, national treasury, government accounting, lottery and public fund; overseeing public organizations; managing international finance and foreign exchange, and strengthening international financial cooperation.

*National Tax Service (NTS)* is in charge of taxation.

*Korea Customs Service (KCS)* is in charge of customs on imported items, enforcement on illegal items including against intellectual property infringement.

*Public Procurement Service (PPS)* is in charge of domestic and foreign procurement for public institutions. *Korea Statistics Bureau (KOSTAT)* is in charge of national statistics.

**Financial Service Commission (FSC):** Monitoring credit system and business practices; planning policy for financial industry supervision; promoting the stability of financial market and fair trading practices; managing accounting standards and audit review; and supervising the securities and futures markets.

*Financial Supervisory Service (FSS)* is a single supervisory organization under the FSC in charge of supervision on financial institutions including banks, securities and insurances.

### **The Board of Audit and Inspection of Korea (BAI)**

Examining the final accounts of national revenues and expenditures; auditing the accounts of the central government agencies; inspecting the works performed by government agencies and their employees; and based on the results, requesting disciplinary actions, correction or improvement.

### **Bank of Korea (BOK)**

Issuing banknotes and coins; formulating and implementing monetary policy; maintaining financial system stability; accepting deposits from and making loans to banks and other financial institutions; serving as the depository of the government and making loans to the government; operating and overseeing the payment systems; managing the official foreign exchange reserves.

## **3. Health and Welfare**

### **Ministry of Health and Welfare (MOHW)**

Providing support for childcare, childbirth, and to vulnerable children; supporting healthy and active aging; managing basic livelihood security, national pension and old-age income security systems; managing the national health insurance system as well as health care system; conducting programs of health promotion, disease control and cancer management; promoting welfare of persons with disabilities; and promoting the development of health industry.

### **Ministry of Food and Drug Safety (MFDS)**

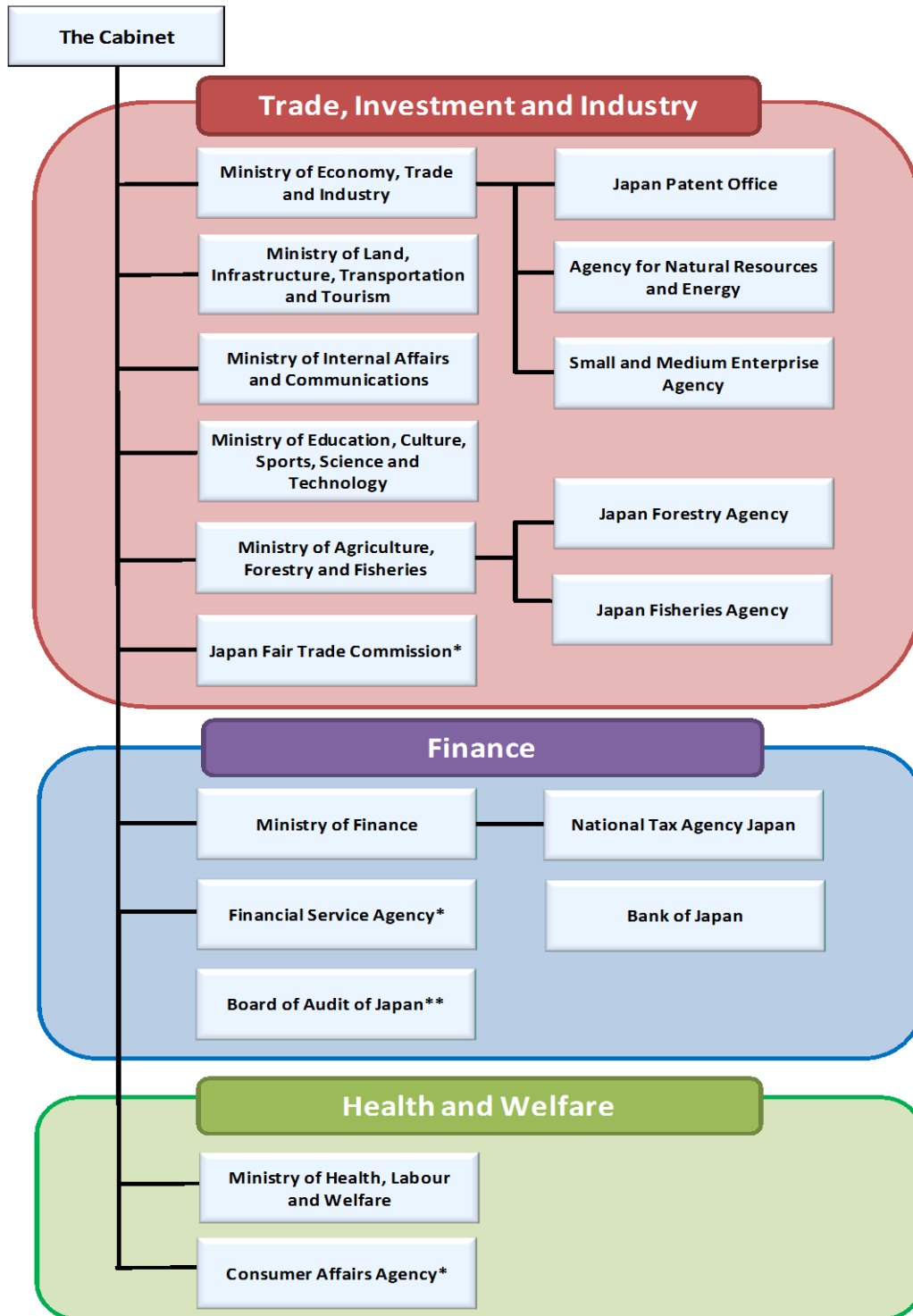
Ensuring food safety; conducting pharmaceutical safety and quality control as well as narcotic safety control; reviewing and approving pharmaceutical manufacturing and traditional medicines; examining and setting standards for new bio pharmaceuticals products, herbal medicines, cosmetics, and quasi drugs; establishing standards, specifications, notifications, and acts on medical device.

### **Ministry of Employment and Labor (MOEL)**

Establishing employment policies, providing unemployment prevention and employment promotion programs; overseeing employment service industry; providing vocational training and skill development support; promoting equal employment for women, the disabled, the aged, youths and minors, foreign workers, etc.; supervising labor standards for both workers and employers; supporting improvement of industrial relations and labor management; preventing industrial accidents.

## ii. Japan

In Japan, the Cabinet coordinates over 10 economy-related government ministries and 6 agencies under them.



\*Financial Service Agency, Japan Fair Trade Commission and Consumer Affairs Agency are under the Cabinet Office.

\*\* Board of Audit Japan and Bank of Japan stand independent of the cabinet, the court or the Diet.

## 1. Trade, Investment and Industry

### **Ministry of Economy, Trade and Industry (METI)**

Promoting technological innovation; protecting intellectual property; developing industrial standards and intellectual foundation; promoting IT use and information security measures; developing an infrastructure for distribution and physical distribution; promoting the administration of products safety and ; developing economic and industrial statistics; formulating trade policy and procedures, promoting international cooperation on trade, financial support, trade insurance, and trade security; creating business environment for SMEs, promoting revitalization of regional economy and town development; promoting manufacturing, information, and service industry; managing chemical substance control; ensuring industrial safety including nuclear safety; ensuring supplies of oil, natural gas, coal and mineral resources; promoting diversification of energy resources and sophisticated use of energy; promoting sophistication of electric power; managing the development of nuclear-related technology; and promoting environment-friendly business and resources recycling.

*Agency for Natural Resources and Energy (ANRE)* is in charge of natural resources and energy issues.

*Japan Patent Office (JPO)* is in charge of administration of intellectual property rights.

*Small and Medium Enterprise Agency* provides various kinds of supports to SMEs.

### **Ministry of Land, Infrastructure, Transportation and Tourism (MLIT)**

#### ○ Infrastructure

Construction and real estate industry including oversea project, urban planning and development, urban renaissance, river facilities, water resource, sewer, road network including highway, and housing development including housing financial service.

#### ○ Transportation

Car safety, car insurance, and car inspection; railway network including urban railway and oversea project; maritime safety, maritime transportation, shipping industry, development and maintenance of ports; development of airport, international aviation network, and air navigation.

### **Ministry of Internal Affairs and Communications (MIC)**

#### ○ Information and Communication Technology (ICT)

Developing ICT policies; promoting research and design, standardization, and international deployment activities; promoting broadcast digitalization, information security and advanced use of ICT; promoting the use of radio waves in food safety, robots, medical treatment, etc.

*The Statistics Bureau* is in charge of national census, statistics researches, official data, and



statistics.

### **Ministry of Education, Culture, Sports, Science and Technology (MEXT)**

Formulating science and technology policies; developing human resources; promoting basic research as well as development of new technology; conducting large-scale research and development in fields such as space, nuclear power, oceans environment and energy; enhancing research infrastructures; promoting international cooperation as well as academia-industry-government cooperation; and ensuring the safety of nuclear energy.

### **Ministry of Agriculture, Forestry and Fisheries (MAFF)**

Ensuring food security and supply; preventing animal and food diseases; supporting agricultural industry and promoting exports of Japanese agricultural products; promoting prevention of global warming and conservation of biodiversity.

*Forestry Agency* and *Fisheries Agency* are in charge of promoting the industries.

### **Japan Fair Trade Commission (JFTC)**

Enforcing Antimonopoly Act; protecting small and medium-sized enterprises; facilitating competition environment and promoting corporate compliance; and preventing government intervention.

## **2. Finance**

### **Ministry of Finance (MOF)**

Fiscal policy including national budget, currency system, foreign exchange, custom system including international custom agreement, and customs/trade statistics.

*The International Bureau* is in charge of international monetary systems and their stability; adjustment of balance of payments; management of Foreign Exchange Special Account; international economic development and cooperation; and oversea loans and investment.

*National Tax Agency Japan* is in charge of fair taxation and collection.

### **Financial Service Agency (FSA)**

Planning on the financial system; supervising and inspecting financial institutions in the private sectors including banks, insurance and securities companies, and foreign exchanges; establishing rules for trading in markets and protecting financial-service customers; establishing business accounting standards; supervising certified public accountants and auditing firms; conducting surveillance of compliance of rules in markets.

### **Bank of Japan (BOJ)<sup>1</sup>**

Implementing monetary policy to maintain price stability; maintaining stability of the financial system; providing settlement assets and payment and settlement services including banknotes; conducting operations settlement of funds among financial institutions; and conducting research on and collecting statistical data of financial systems and financial markets.

*The International Department* is responsible for trading foreign currencies and conducting financial operation with central banks of other countries.

### **Board of Audit of Japan <sup>2</sup>**

Auditing the national budget execution.

## **3. Health and Welfare**

### **Ministry of Health, Labor and Welfare (MHLW)**

#### ○ Health

Managing medical care system; promoting pharmaceutical industry; prevention against infectious diseases; ensuring the safety of drugs and medical devices; promoting environmental health-related business and securing water supply system; establishing food and additive standards; and ensuring food safety including inspection of radioactive materials and imported food.

#### ○ Labor

Securing standards for labor condition; implementing compensation policy for workers; administering industrial safety and health; promoting unemployment insurance, vocational training and career consultation; and managing issues related to foreign workers.

#### ○ Welfare

Providing welfare service for children, persons with disabilities, elderly, etc.; managing insurance system and pension system.

### **Consumer Affairs Agency (CAA)**

Protecting consumers' interest; implementing the consumer-related laws; collecting consumer accident information, and providing support for solving disputes.

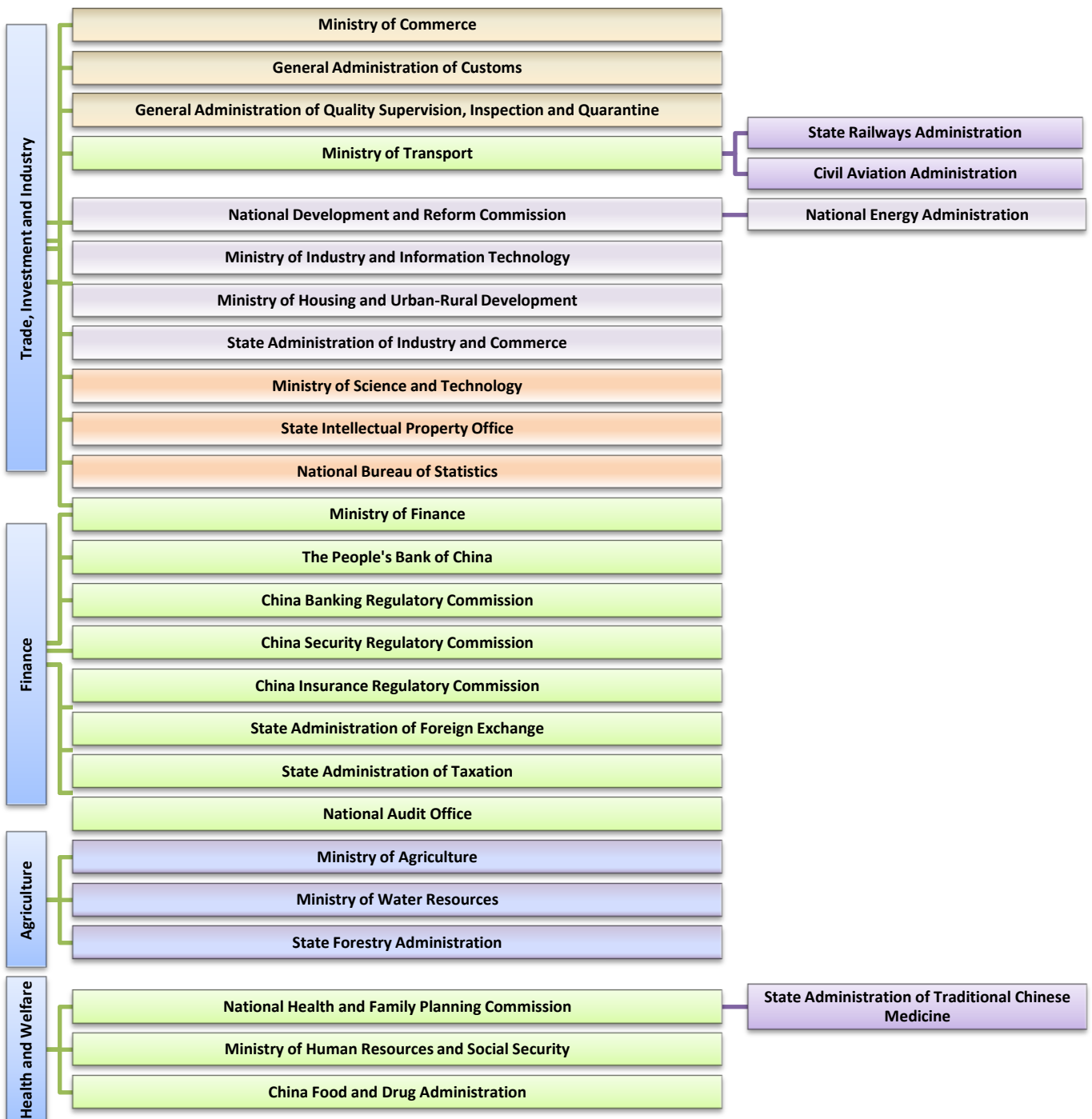

### iii. China

The State Council, as the central government of China, administers the national economy. Under the State Council, there are 25 ministries and 4 subordinate agencies with more than 100 departments/bureaus related to the running of the economy.



The following are foreign-related functions of each ministry/agency:

## 1. Trade, Investment and Industry

**Ministry of Commerce (MOFCOM)** (formerly Ministry of Foreign Trade and Economic Co-operation (MOFTEC) : managing foreign trade, investments, foreign aid, overseas projects, international labor services, consumer protection, market competition and free trade agreements.

**General Administration of Customs (GAC):** customs supervision for entry and exit of the mainland China; collecting duty; supervising processing-goods in tariff-free areas; combating smuggling; and managing import and export statistics.

**General Administration of Quality Supervision, Inspection and Quarantine (AQSIQ):** administering quality management, metrology, standardization; enforcing health quarantine and animal and plant quarantine; inspecting imported and exporting food safety; implementing the inter-governmental agreements signed by the Ministry of Agriculture; signing subsidiary import-export agreements/protocols on animal and plant quarantine; implementing the WTO Agreement on Technical Barriers to Trade (TBT Agreement) and the WTO Agreement on the Application of Sanitary and Phytosanitary Measures (SPS Agreement).

**Ministry of Transport (MOT):** administering railway, road, air and water transportation regulations. Its function includes international cooperation on water and land transport.

Under the Ministry, there are *State Railways Administration (SRA)* and *Civil Aviation Administration (CAAC)*.

**National Development and Reform Commission (NRDC)** (formerly the State Planning Commission): formulating macroeconomic plans and policies; facilitating strategic economic restructuring, particularly economic system reform and adjustment; managing fixed asset investment, regional economy development, rural economy development, social development, industry development (from basic to high-tech industries), key project supervision, employment and income distribution, price supervision and anti-monopoly.

There are 26 departments under the NRDC, among which the Department of Trade and the Department of Foreign Capital and Overseas Investment are in charge of issues relating foreign trade and investment; the Department of Resource Conservations and Environmental Protection is in charge of the Trilateral Circular Economy Model Base.

*National Energy Administration (NEA)* is responsible for formulating and implementing energy

strategies and energy industry standards for coal, oil, natural gas, electricity, nuclear power, hydro power, and biomass power, coal fuel, fuel ethanol and other new energies or renewable energies; promoting energy conservation and comprehensive utilization of resources in energy industries.

**Ministry of Industry and Information Technology (MIIT):** formulating industrial policies and monitoring industrial projects; nurturing high-tech and ICT industries; supporting small and medium enterprises; managing raw materials such as iron and steel, nonferrous metals, rare earth, petrochemical (excluding oil refinery), chemical industry (excluding coal based fuel and ethanol); managing heavy industries such as manufactures of machinery, automobile, civil aviation, civil shipping; managing consumer industries such as textile, food, pharmacy, household electronic appliances; facilitating the convergence of telecommunication, broadcasting, and information technology; monitoring internet security; and managing wireless communication.

**Ministry of Housing and Urban-Rural Development (MOHURD):** establishing engineering construction standard system; supervising the construction market; organizing construction enterprises to participate in international project contracting; promoting international construction labor cooperation; undertaking supervision on construction quality and safety; and promoting energy conservation and emission reduction in rural development.

**State Administration for Industry and Commerce (SAIC):** conducting market supervision and administrative enforcement; managing enterprise registration; ensuring goods quality and food safety in circulation process; organizing consumer rights protection activities in related service sectors; taking anti-monopoly measures and managing dealer/agent activities; administering trademark registration and management; and providing guidance to advertising industry.

**Ministry of Science and Technology (MOST):** formulating national science and technology policies; carrying out plans on research and design of high-technology and social welfare related technology; supervising science and technology projects; and promoting science and technology cooperation in the fields of bio-technology, remote sensing, nuclear energy, among others.

**State Intellectual Property Office (SIPO):** administering patent work and other affairs related to intellectual property rights.

**National Bureau of Statistics (China):** collecting and publishing statistics related to the economy and society at national and local levels.

## 2. Finance

**Ministry of Finance (MOF):** drafting fiscal development plan as well as laws on accounting management; implementing budget and final account; managing government funds, treasury bills, lottery and national treasury; managing international payments, non-trade foreign exchanges within the fiscal budget, and state-owned assets of financial enterprises; drafting plan for debt balances and limits, conducting unified management on government debt; guiding and managing public audit.

**The People's Bank of China (PBC):** developing and implementing monetary policy; managing foreign exchange; organizing anti money laundering activities; managing credit industry; administering the cross-border settlement of RMB; monitoring and preventing financial risks.

**China Banking Regulatory Commission (CBRC), China Security Regulatory Commission (CSRC), and China Insurance Regulatory Commission (CIRC):** managing supervision and regulation of banks, security companies and insurance companies, respectively.

**State Administration of Foreign Exchange (SAFE):** managing national foreign exchange reserves, gold reserves and other national foreign assets.

**State Administration of Taxation (SAT):** imposing taxes on import and export commodities as well as export-tax refunds; negotiating and signing of international taxation agreements; taking international anti tax avoidance measures; collecting VAT, consumption tax, sales tax and vehicle purchase tax (not including those levied by customs).

**National Audit Office (CNAO):** auditing budget execution and other government revenues as well as expenditures of government organizations, state institutions, the Central Bank and the State-owned enterprises.

## 3. Agriculture

**Ministry of Agriculture:** overseeing agriculture, fishery, animal husbandry, foodstuffs, processing of agricultural products, agricultural mechanization, higher education and research of agricultural sciences; improving the quality and safety of agricultural products by formulating regulatory policies on genetically modified products, and supervising the licensing of seeds, feedstuffs, pesticides, and veterinary drugs; formulating and signing inter-governmental framework agreements

on animal and plant quarantine.

**Ministry of Water Resources (MWR):** formulating water resources development plans and policies; managing water resource conservation and protection; promoting flood control and drought relief, control of soil and water losses.

**State Forestry Administration:** formulating and implementing policies and regulations relating forest resource management, forestry protection and ecological improvement.

#### 4. Health and Welfare

**National Health and Family Planning Commission:** drafting laws and regulations on public health, family planning and traditional Chinese medicine; formulating plans on disease prevention and control; setting up food safety standard; monitoring the safety of new food ingredients and additives; formulating laws and regulations on the purchase, delivery and use of pharmaceutical drugs; providing health information, raises health awareness; and monitoring the quality of health services.

*State Administration of Traditional Chinese Medicine (SATCM)* supervises health care, disease-prevention, health preservation, rehabilitation and clinical prescription of traditional Chinese medicine (TCM), and formulates regulations and technical standards on TCM.

**Ministry of Human Resources and Social Security:** formulating national labor policies, standards, laws and regulations; managing social security; improving capital-labor relation; providing vocational training; and managing social insurance, unemployment insurance, injury insurance, medical insurance and pension system.

**China Food and Drug Administration (CFDA):** monitoring the quality of food, cosmetics and drug.

### III. Existing and Potential Areas of Cooperation

The report has compiled a database of economy-related ministries/agencies at the department level (Annex II) and classified them into the following four tiers:

*Tier 1: Existing mechanisms of trilateral economic cooperation*

*Tier 2: New cooperative areas with single ministry/agency of each government to match*

*Tier 3: New cooperative areas where multiple ministries/agencies are involved*

*Tier 4: Cooperative area where one or two countries do not have corresponding ministries/agencies*

In view that Chinese ministries/agencies have more detailed division of labor at the department level, the classification of these tiers is mostly based on Chinese departments. The list of departments is not exhaustive as a result of eliminating departments presumably irrelevant to international economic cooperation. Also, the matching of possible corresponding ministries/agencies is based on their functions listed in open sources, and to some extent subjective, therefore requires verification by related ministries/agencies and their departments.



## Tier-1. Existing Mechanisms of Trilateral Economic Cooperation

Up till now, there have been 18 major trilateral cooperative mechanisms in the field of economy, 11 of which are at the ministerial level. The following list is about the participating ROK, Japanese and Chinese ministries in these mechanisms. Highlighted mechanisms are at the ministerial level.

As a result of examining departments under the existing ministerial-level mechanisms, it is found that several agenda are not yet tabled for discussion in such ministerial mechanisms as Trade and Investment, Transport and Logistics, and Agriculture. The following list is the corresponding departments under these mechanisms by the possible cooperative agenda.

## 1. Trade and Investment

Being the main mechanism for overall economic cooperation among the three countries, the Trilateral Economic and Trade Ministers' Meeting still has potentials to take up more agenda for discussion as well as to explore cooperative projects on such issues as WTO, trade in services, fair trade and foreign direct investment.

Trademark is not taken up at the Trilateral Policy Dialogue among the Intellectual Property Offices, because in China the management of trademark is by a different government agency, i.e. State Administration of Industry and Commerce. At present, bilateral heads' meetings of trademark offices have been held. It is recommended that the three agencies develop a trilateral mechanism to harmonize related rules and to share effective trademark examination procedures.

### Tier-3. New Cooperative Areas Where Multiple Ministries Are Involved

#### 1. Competition Policy

Anti-monopoly laws of China consist: 1) Monopoly agreement; 2) Abuse of market dominance; 3) Concentration of business operators; 4) Abuse of administrative power to eliminate or restrict competition. Among these, 1) 2) and 4) are enforced by the State Administration of Industry and Commerce (SAIC) while 3) is administered by Ministry of Commerce. On the other hand, enforcement of competition policy in Japan and ROK are exclusively administered by Japan Fair Trade Commission (JFTC) and Korea Fair Trade Commission (KFTC), respectively. SAIC, JFTC and KFTC have held bilateral meetings between each other, which might serve as foundation for a trilateral cooperation framework.

#### 2. Energy

The trilateral consultative mechanism on energy cooperation has not been established, although the three countries stressed on several occasions the importance of trilateral cooperation on energy security as well as renewable energy. Energy cooperation includes a cluster of sub-areas such as energy security, energy efficiency technology, renewable energy, etc. Nevertheless, the three countries have several representative agencies for energy-related issues. Agenda for trilateral energy cooperation can be identified amongst them.

### 3. Food Safety

In 2009, the 3<sup>rd</sup> Tripartite Health Ministers' Meeting (THMM) signed an *MOU on Food Safety* to strengthen information exchange on food safety laws, inspection procedures and control measures. In the ROK, the authority over food safety issues has been transferred to the newly established Ministry of Food and Drug Safety since 2013. Consequently, the agenda of food safety was excluded from the THMM. It is advisable that the three countries re-establish a cooperative mechanism on food safety, and further strengthen cooperation in food production, distribution, monitoring, etc.

### 4. Pharmaceuticals

The Director-General level meeting on pharmaceutical affairs has been held by the three pharmaceutical bureaus to conduct a joint research on clinical trials since 2008. Same as the area of food safety, the authority over pharmaceutical issues was transferred to the Ministry of Food and Drug Safety in the ROK and the THMM is no longer in charge of the pharmaceutical issues. Thus it is recommended that the ministries and agencies in charge of pharmaceutical issues re-establish a cooperative framework and extend into related areas such as cosmetics and medical devices.

### 5. Sanitary and Phytosanitary Measures (SPS)

The CJK FTA negotiations highlighted the necessity of balance between SPS enforcement and trade facilitation. The SPS-related issues encompass many ministries, such as those in charge of animal and

plant quarantine, food quarantine, food safety regulations and assessment, import standards. Efforts to harmonize those rules are of significance.

## 6. ODA / Development Assistance

The implementation of foreign aids involves supervising ministries, coordinating body and executing agencies, etc. In the ROK, the Committee for International Development Cooperation (CIDC) under the Prime Minister decides ODA policies and functions as a coordinating body, whereas the Foreign Ministry and Finance Ministry supervise concessional loans and grants respectively. Unlike the ROK, overall ODA / development assistance policies are coordinated by the Ministry of Foreign Affairs in Japan, and by the Ministry of Commerce in China, respectively.

## **Tier-4. Cooperative Area Where One or Two Countries Do Not Have Corresponding Ministry/Agency**

### **Government Procurement**

The Joint Study on CJK FTA underscored the importance of coordination of government procurement policy for fair and open procedures. The ROK conducts procurement through a single government-wide e-procurement system, which the National Procurement Service manages. In China, the Ministry of Finance administers the laws and supervises the implementation of the government procurement. However, Japan does not have a centralized administrative body for the unified management of procurement.

## IV. Findings

- Chinese ministries/agencies have more detailed mandates than the ROK and Japanese counterparts. Only 11 out of 25 economy-related ministries/agencies in China (44%) have joined ministerial-level mechanisms. Future cooperation could be thus conducted by these non-participating ministries of China with the ROK and Japanese corresponding ministries.
- Departments of the Chinese ministries/agencies are more specifically divided than their ROK and Japanese counterparts. Tasks at the department level in China correspond to those at the division level in the ROK and Japan.
- The existing ministerial-level mechanisms can dig deep into the department level to search for specific fields of future cooperation, particularly in the areas of trade and investment, transport and logistics, and agriculture.
- Due to different arrangement of the functions among ministries/agencies in the three countries, there are areas, such as e-commerce, trademark, fisheries, forestry and pharmaceuticals, not covered by existing mechanisms.

## V. Recommendations

- **More vice minister and director-general level mechanisms**

Due to the fractionized division of labor among the Chinese ministries/agencies, the same Korean/Japanese minister would have to participate in more than one mechanism as the number of ministerial mechanisms grows. To avoid such overlapping participation, vice-minister level as well as director-general level mechanisms should be explored.

- **Establishing working groups**

To avoid the discrepancy of administrative levels among the three delegations, it is advisable to set up “working groups” in which three countries’ officers can work jointly in the capacity of “experts.”

- **Finding out the leading ministry/agency**

For the areas where multiple ministries/agencies are involved such as energy and food safety, it is necessary to find out the leading agency that can take a major role for initiating trilateral cooperation.
