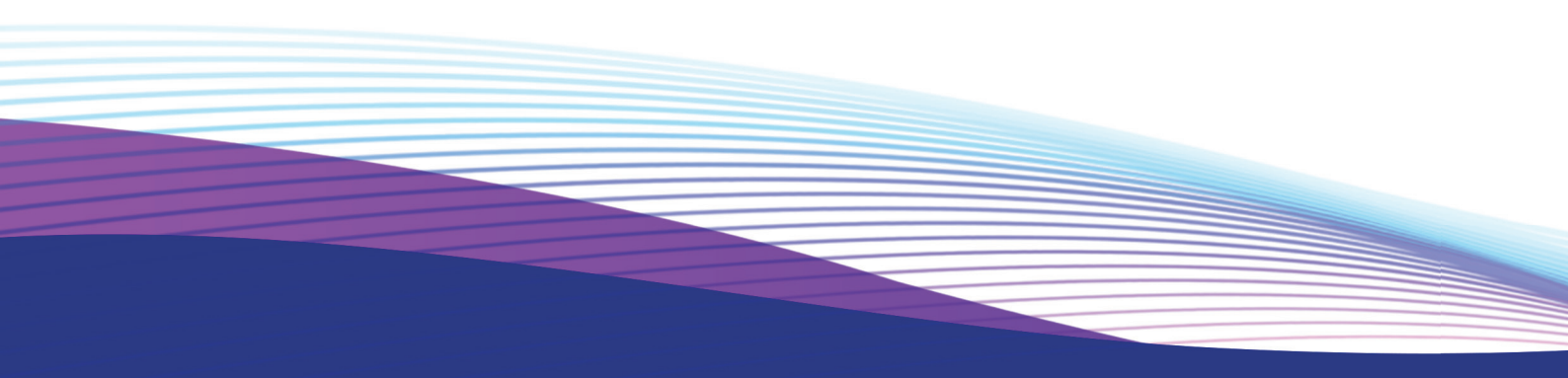

# Speaker Biographies



## YAN Liang

Deputy Secretary-  
General, Trilateral  
Cooperation Secretariat  
(TCS)

Mr. Yan Liang, born on August 20, 1974, is currently serving as the Deputy Secretary-General of the Trilateral Cooperation Secretariat (TCS) for China, Japan, and the ROK. He graduated from Nankai University in 1997 with a Bachelor's degree in Literature and later obtained a Master's degree in Public Administration from the National Graduate Institute for Policy Studies in Japan in 2005.

Mr. Yan's career began in 1997 at the Ministry of Foreign Affairs of China. He has since accumulated extensive diplomatic experience, including positions at the Chinese Embassy in Zambia, various roles within the Ministry of Foreign Affairs, and a tenure as Second Secretary at the Office of the Commissioner of the Ministry of Foreign Affairs in Hong Kong. His international experience is further highlighted by his service as the Deputy Secretary-General of the Joint Monitoring and Evaluation Commission in South Sudan under the Intergovernmental Authority on Development (IGAD).

In addition to his diplomatic roles, Yan has contributed significantly to regional cooperation and development, having served as the Director of the Secretariat at the United Nations Association of China and as a Senior Advisor and Chair of the Monitoring and Verification Mechanism for the Ceasefire and Transitional Security Arrangements in South Sudan. His current role at TCS involves fostering trilateral cooperation and enhancing diplomatic relations among China, Japan, and the ROK.



## Koji Hachiyama

Deputy Director-General for Trade Policy, METI (Ministry of Economy Trade and Industry)

Koji Hachiyama has been serving as Deputy Director-General for Trade Policy, METI (Ministry of Economy Trade and Industry) since July 2024. Mr Hachiyama started his career in the Ministry of International Trade and Industry of Japan (now known as the Ministry of Economy, Trade, and Industry) in 1992 and served in various positions, including the Embassy of Japan in Indonesia (1997-2001) throughout the years.

Before current position, Mr Hachiyama served as the COO (Chief Operating Officer) of the Economic Research Institute for ASEAN and East Asia (ERIA) for 5 years (from 2019 to 2024). And He served as the Counsellor in the National Strategy Office of Information Communications Technology (ICT), the Cabinet Secretariat of Japan (from 2017 to 2019). From 2014 to 2017, He served as the Director of Information Technology (IT) Department in JETRO New York and the Head of the New York Representative Office of Information Technology Promotion Agency (IPA), Japan. Mr Hachiyama obtained his Bachelor's and Master's degree in Engineering from the Tokyo Institute of Technology, Japan.



## **KIM Jongchul**

Director General, International Trade Relations, Ministry of Trade, Industry and Energy of the ROK

Dr. KIM Jong Chul, born on July 26, 1969, is currently serving as the Director-General of the International Trade Relations Bureau at the Ministry of Trade, Industry and Energy (MOTIE) of the Republic of Korea. Dr. KIM graduated from Seoul National University in 1992 with a B.A. in Hispanic Language and Literatures. He later obtained an MBA from KAIST (Korea Advanced Institute of Science and Technology) and a Ph.D. in Business Administration from aSSIST (a Seoul School of Integrated Sciences & Technologies).

Dr. KIM began his career in 1998 at MOTIE. Throughout his career as an economic bureaucrat, he has accumulated extensive expertise in public policy related to trade, industry and energy. Serving as Deputy Director from March 1998 to December 2004, he worked at the Industrial Standards Division, the Information Division, and the Asia and Oceania Division at MOTIE, as well as at the Embassy of the Republic of Korea in the People's Republic of China. As Senior Deputy Director from December 2004 to August 2012, he was involved with the FTA Promotion and Policy Adjustment Authority at MOEF, the Personnel Division and the Industrial Policy Division at MOTIE. He also served at the Consulate-General of the Republic of Korea in Shanghai, China. From August 2012 to October 2018, he held the position of Director, leading the Policy and Planning Team for the Korea Free Economic Zone, as well as the Electric Market and Smart Grid Division, the Metals and Chemicals Division, and the General Services and Personnel Affairs Division at MOTIE.

He was Director-General of the Korea Investment Service Center at MOTIE from February 2019 to March 2020 and subsequently served as Director-General of the Current Capabilities Program Support Department at DAPA from March 2020 to January 2022. Since January 2022, Dr. KIM has been serving as the Director-General of the International Trade Relations Bureau at MOTIE.

Yang Yi, Associate Dean of the school of management, Zhejiang University. He is the author of "The World of Dual-Brain", the third volume of "General System Theory", "Social Brain - The Formation and Evolution of Wisdom Sharing System", and others. During the period from 2006.3 to 2010.12, he pursued a doctoral degree with the same educational level at the Institute of Development and Reform of Central University of Finance and Economics (majoring in International Finance). From 2008.3 to 2014.12, he studied and worked as an exchange professor at the China Research Center of the University of Hawaii at Manoa (majoring in Management Philosophy). From 2010.1 to 2011.9, he was employed at the Mobile Intelligence Research Institute of Yuanzheng Innovation Research Institute of Zhejiang University. From 2011.9 to 2022.8, he worked at the Research Center of Science, Technology and Industrial Culture of Zhejiang University. Since 2022.8, he has retired and now serves as a supervisor at the Innovation and Entrepreneurship Education Center of the School of Philosophy of Zhejiang University and a senior think tank for domestic and foreign organizations.

Mr. Peng has continuously deepened intergovernmental exchanges and dialogue on digital economy policies, established multilateral digital economy partnerships, actively negotiated digital economy issues by international organizations, and expanded cooperation in frontier areas.

Meanwhile, he serves as the economic development consultant or city partner for many local governments, comprehensively promoting the industrial matchmaking between tens of thousands of CECC member companies and local governments and realizing the effective communication between member companies and governments.

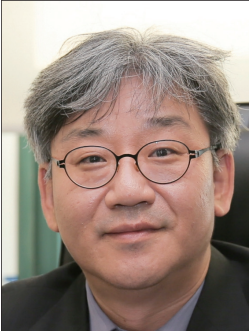


## **TAKENAGA** **Shuichi**

CEO, Aucfan Co., Ltd.

As the President and CEO of Aucfan Co., Ltd., TAKENAGA Shuichi's extensive business career began early. In 2000, he started selling goods through auction listings as a sole proprietor while attending university. In 2004, he established and assumed the role of president and representative director of Defactostandard, Ltd., which is currently focusing on purchasing used brand-name goods (Brandear). In 2006, he acquired the Auction Statistics Page and began performing media management. The following year, in 2007, he established the media business through an incorporation-type split from Defactostandard, Ltd. and founded Aucfan Co., Ltd., taking on the role of the office of president and CEO. In 2013, it was listed on the Growth sections of the Tokyo Stock Exchange (securities code: 3674). In 2015, he expanded the group by acquiring NETSEA, one of Japan's largest B2B wholesale shopping malls, along with ReValue, a slow-moving inventory liquidation service, and TATEMPO Guide, a centralized management system for online shops. When it comes to 2020, they were integrated into a Re-INFRA COMPANY. In 2022, his business further expanded as he acquired offline trade fair services OSR Net and Osaka Senba Wholesale Marketing while offering Amacode, a dedicated app for Amazon sellers, following business transfer. That year, an overseas subsidiary "Aucfan China" based on Hainan Island, China, was also established. Besides, He entered into a strategic partnership with Zhejiang China Commodities City Group Co., Ltd., which operates Yiwu Market, one of the largest wholesale markets in the world in 2023, and launched NETSEA CHINA, a B2B export platform forged a business alliance with YeePay, one of China's largest payment service providers in the same year. Most recently, in 2024, he concluded a strategic partnership agreement with Sinomach Hainan Development Co., Ltd., a group company of Sinomach Group, a major Chinese conglomerate, and opened "Japan Tokyo Yiwu Selection," a China to Japan B2B offline platform, as well as "Yiwu Japan Pavilion," Japan to China B2B offline platform, marking Japan's first national pavilion in the Yiwu Market.





## LEE Dong Il

Dong Il Lee is a professor of Marketing at the School of Business at Sejong University. He is also the 29th president of KODIA (Korea Distribution Association) and served as the president of KACST (Korea Academy of Commodity Science and Technology). He is the chief researcher at the Online Research Center of KOLSA (Korea Online Shopping Association). He was involved in several government policy-making workgroups, especially in the online shopping industry.

His research areas include trust building of e-Commerce, online advertising management, online consumer's path analysis, and online buzz diffusion. He has published in Journal of Business Research, Journal of Global Academy of Marketing Science, Decision Support Systems and other journals. He received Ph.D. degree at Seoul National University and also graduated with his MS and BA degree in SNU business school.

Upon the agreement signed by China, Japan, and the ROK, TCS was inaugurated in Seoul, ROK, in September 2011.

### Objective

Contribute to the further promotion of cooperative relations among the three countries by providing support for the operation and management of the trilateral consultative mechanisms among the parties and by facilitating the exploration and implementation of cooperative projects.

4. Compile trilateral mechanism information into database and publish annual Progress Report of the Trilateral Cooperation. Conduct research on important issues related to the Trilateral Cooperation, manage TCS website and mechanism website, and promote understanding of the Trilateral Cooperation.
